### Conditions Of Entry & Sale

1. All greyhounds are entered at owner's risk
2. A greyhound will only be accepted for Sales Trials by Greyhound Trader on the terms that the Company and/or the Stadium shall not be liable for any damage, loss or injury to such greyhound or to the owner, trainer, agent or handler of such greyhound from any cause whatsoever occurring in or about the Stadium
3. Where an owner, trainer, agent or handler of the greyhound does not comply with testing procedures including the re-kennelling of the greyhound post trial, this greyhound will be immediately withdrawn from the auction
4. In the event of a greyhound being sold at a Greyhound Trader Sale the Registered Owner is required to update the RCETS system following the Sale. The name of the purchaser will be provided to the Registered Owner by Greyhound Trader
5. All greyhounds trialled must be presented for auction
6. Identity Card of any greyhound not sold on the bench at the auction will be retained by Greyhound Trader for 14 days
7. Entry fee of £50.00 sterling required per greyhound
8. All auctions will be conducted in sterling and the Vendor will be liable for a 5%+VAT commission charge on the sale of their greyhound. The VAT charge is applicable on the commission charge element only
9. All monies owing to the Vendor will be retained for 21 days from the date of the sale to allow for a non-fighter warranty and a negative POR
10. Monies owing to the Vendor will be transferred via bank transfer to your chosen account immediately after the 21 days period is completed
